Pursuant to the Regulation 30 read with Part A of the Schedule III of the SEBI Listing Regulations and Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 ("**Circular**"), we would like to inform you that the Company has received an order from the office of the Additional Commissioner (Appeal) State Tax Chhattisgarh (SGST), for the period April 2019 to March 2020 confirming the demand of ₹10,57,319 (Tax ₹6,21,532 /-, interest – ₹3,73,634 and penalty of ₹62,153 /-)

Based on the merits of the matter, prevailing law and advice of the consultant, the Company is planning to appeal against this order before the GST Appellate Tribunal and reasonably expects favourable orders from the appellant authorities.
