Details of the violation(s)/contravention(s) committed or alleged to be committed;	V Guard filed a trademark infringement and passing off suit against the Company for the alleged infringement of its trademark "PEBBLE." The Company has been using the mark "Crompton PEBBLE" for its electric iron, while V-Guard has been using the mark "PEBBLE" for water heaters since 2013. V-Guard claimed prior use of the mark since 2013, whereas the Company commenced its use in 2020. An interim order was initially passed restraining the Company from using the mark "PEBBLE" in any manner until the final disposal of the suit. On January 29, 2025, the matter decreed in favor of V Guard.
