The Last date for casting of vote through e voting by the Members was 28.03.2015 before 6.00pm.

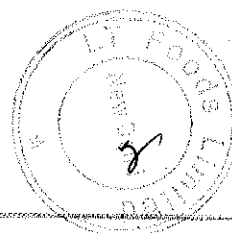
The Last date for casting of vote through physical voting and to receive the postal ballot Forms duly completed and signed by the Members was 21.03.2015 before 6.00pm.

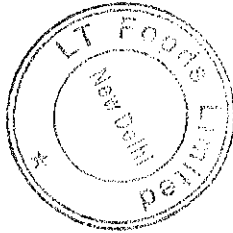
