Pursuant to Regulation 30 of the Listing Regulations, we wish to inform that Dalmia Cement (Bharat) Limited ("**DCBL**"), a material wholly owned subsidiary of the Company, has received a Provisional Attachment Order dated March 31, 2025 (received on April 15, 2025) issued by the Jt. Director, Enforcement Directorate ("**ED**"), Hyderabad, regarding provisional attachment of land of DCBL.

The provisional attachment by ED emanates from an earlier case registered by the Central Bureau of Investigation ("**CBI**") in 2011 wherein they had made certain allegations against DCBL regarding investments in Bharathi Cement Corporation Private Limited. The matter is currently sub-judice before the CBI Court in Hyderabad.

DCBL is examining the aforesaid Order and basis legal advice, will take appropriate steps to defend the matter.

The details as required under Regulation 30 of the Listing Regulations read with SEBI circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13,2023 are provided in the Annexure hereto.
