## Sub: Composite Scheme of Arrangement - Record date and Listing of Shares

We wish to inform you that the Composite Scheme of Arrangement amongst Lily Commercial Private Limited ("Transferor Company"), DCM Shriram Industries Limited ("DCMSR" or "the Company" or "Transferee Company"), DCM Shriram Fine Chemicals Limited ("DSFCL" or "Resultant Company 1") and DCM Shriram International Limited ("DSIL" or "Resultant Company 2") and their respective shareholders and creditors ("the Scheme"), as sanctioned by the Hon'ble National Company Law Tribunal ("NCLT"), New Delhi Bench vide Order dated November 21, 2025, the Company has fixed Friday, December 19, 2025, as the "Record Date" to ascertain eligible shareholders of the Company who shall be issued and allotted 1 (one) share (face value of INR 2/- each fully paid up) in DSFCL and DSIL, for every 1 (one) share (face value of INR 2/- each fully paid up) held in DCMSR by them as on the Record Date (as per Share Entitlement Ratio under the Scheme). In this context, we would like to bring to your attention, inter alia, the following:

- a) In terms of the Scheme, the Chemical business and Rayon business undertakings of DCMSR has been demerged into DSFCL and DSIL respectively. The Appointed Date as per the Scheme is April 1, 2023.
- b) DCMSR shall continue to be a listed entity. Pursuant to the Scheme, DCMSR shall carry on the sugar business undertaking including its power and alcohol business.
- c) On the Record Date, the share price of DCMSR shall be adjusted to take into account the demerger of the Sugar business undertaking, through a price discovery mechanism of the stock exchanges.
- d) Upon finalization of the list of eligible Shareholders of DCMSR, the shares in DSFCL and DSIL shall be allotted and thereafter, such shares shall be listed on the Stock Exchanges, viz., BSE and NSE.
- e) Guidance on 'Cost of Acquisition' of equity shares in DCMSR and equity shares in DSFCL and DSIL will be communicated to you in due course.
