Sub: Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ["Listing Regulations"] - Update on Restoration of Soda Ash Production

With reference to our earlier communications dated June 14, 2023, July 4, 2023 and October 12, 2023 and in compliance with Regulation 30(4) read with Para B of Part - A of Schedule III to the Listing Regulations and other applicable provisions, if any, we hereby provide update on mechanical breakdown of CO₂ gas compressor in our Soda Ash Plant.

We wish to inform you that the new parts from the Original Equipment Manufacturer (OEM) has reached the plant & is to be fixed in due course of time through minimal production downtime. Presently, the plant operation has been elevated to 90% capacity by doing internal changes.

We assure our shareholders that the Management is committed to maintain highest possible level of operational efficiency & risk management in the production process of the Soda Ash Facility and will keep the shareholders updated in due course of time.
