**Sub: Clarification on Increase in Volume**

Dear Sir,

With reference to your letter reference no. NSE/CM/Surveillance/15635 dated 14<sup>th</sup> July 2025 received vide e-mail of even date, seeking clarification on the increase in volume traded across the exchanges in recent past, we would like to mention that the Company has, from time to time, intimated all events and information which may have an impact on the operation and performance of the Company which include price sensitive information and such disclosures as required pursuant to provisions of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") to the exchanges where the securities of the company are listed (i.e. BSE Limited ("BSE") and National Stock Exchange of India Limited ("NSE") collectively referred to as ("Stock Exchanges")). Further, there is no change in any information nor there are any impending announcements, as on date, except those filed with the Exchange, which in the opinion of the Company may have bearing on the price/ volume behavior of the securities of the company on the Stock Exchanges.

The recent submission made by the company to the Stock Exchanges pertains to the Investor meeting held on 11<sup>th</sup> July, 2025.

Therefore, the movement in volume of Company's securities on your exchange or the stock exchanges is purely due to market conditions and apparently market driven on which the company neither has any control nor has knowledge of reasons thereof and since the shares of the company are freely traded on the exchange platform, the Company has no comment to offer on the volume movement of its security.

The trading window for the designated persons and its immediate relatives is also closed from 01<sup>st</sup> July 2025 and shall remain to be closed upto 48 hours of declaration of unaudited financial results of the company.

The company shall keep the Stock Exchanges duly informed of any information as may be required under said Regulation as and when any such event occurs/information is available.
