Pursuant to Regulation 30, Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the Company has received an order dated 12th March 2025 from the Employees' Provident Fund Organisation (EPFO), Regional Office, Kukatpally, Hyderabad.

ii. Nature and Details of the Action(s) Taken, Initiated or Order(s) Passed:

An order under Section 7A of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952, has been issued, directing the Company to pay an amount of ₹8,67,291/- (Rupees Eight Lakh Sixty-Seven Thousand Two Hundred and Ninety-One Only) towards non-payment of PF dues for the period from February 2007 to August 2022.

iii. Date of Receipt of Direction or Order, including any Ad-Interim or Interim Orders, or any other Communication from the Authority:

The inquiry under Section 7A of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952, was initiated vide Summons Notice No. TS/RO/KKP/II/Compliance/Summons/2426349/2022 dated 07-10-2022. The inquiry was conducted on several dates, including virtual hearings and physical appearances, from 04-11-2022 to 18-02-2025.

The final order was issued on 12th March 2025 after considering the submissions and evidence presented during the inquiry, as well as the report submitted by the Enforcement Officer on 17-01-2025.

iv. Details of the Violation(s)/Contravention(s) Committed or Alleged to be Committed:

Non-payment of Provident Fund dues for eligible employees from February 2007 to August 2022 as per the provisions of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952.

v. Impact on Financial, Operational, or Other Activities of the Listed Entity, Quantifiable in Monetary Terms to the Extent Possible:

The financial impact amounts to ₹8,67,291/-.
