The Board Meeting started at 2pm and closed at 5.15 pm.

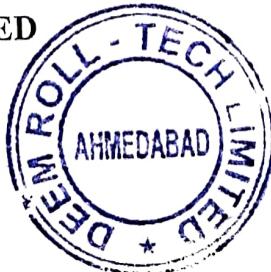

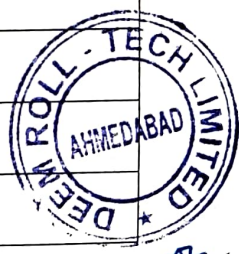

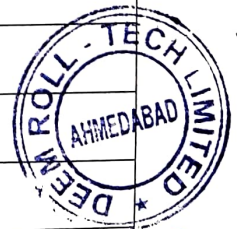
