**Sub: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Changes in Senior Management Personnel of the Company**

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations'), we wish to inform you that the Board of Directors, based on the recommendations of Nomination and Remuneration Committee, have decided that Mr. Shobhit Mehrotra who has been associated with the Company since February 16, 2004 shall cease to be the Head – Fixed Income of the Company w.e.f. March 7, 2026 due to attaining superannuation age as per the Company's Policy and Mr. Anil Bamboli, currently serving as Senior Fund Manager – Fixed Income, shall be the Head – Fixed Income w.e.f. March 7, 2026.

Further, the Board has also decided to retain Mr. Mehrotra and utilize his rich experience and expertise in the areas of Fixed Income and credit analysis for the benefit of the Company, and accordingly, he shall take over a new role of Head – New Initiatives – Fixed Income w.e.f. March 16, 2026. Both Mr. Mehrotra and Mr. Bamboli shall report to Mr. Navneet Munot, Managing Director & Chief Executive Officer and form part of Senior Management Personnel of the Company in accordance with the Regulation 16 of the Listing Regulations.

The Board of Directors of the Company have today i.e. March 6, 2026, approved the above changes to the Senior Management Personnel of the Company.
