Sub: Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) regarding the order passed by Jaipur Consumer Court for payment of Compensation to the customer.

Dear Sir/Madam,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”), we hereby inform you that the Company has received a judgment order in the matter of *Shakeel Ahmeed vs. Deltic Scooty Delhi and Supreme Electric Scooter* – Complaint No. 77 of 2022. The said order was received by the Company through courier on March 12, 2026, in relation to compensation payable to a customer for damages allegedly caused due to a Deltic Scooter.

The complaint was filed before the Consumer Court seeking directions for either full repair of the electric scooter or refund of the purchase amount of ₹83,200 along with interest at the rate of 24% per annum, along with compensation of ₹1,00,000 for mental agony and financial loss and ₹21,000 towards advocate fees. Upon hearing the matter, the Hon’ble Consumer Court directed the repair of the electric scooter and awarded compensation of ₹6,000 for mental agony and ₹4,000 towards advocate fees.

The details of the aforesaid litigation had already been disclosed in the IPO Offer Documents of the Company. Upon receipt of the above-mentioned judgment order and payment of the compensation as directed therein, **the matter now stands concluded.**
