Sub: Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Receipt of Order from the Office of the Principal Commissioner of Customs (Port), Kolkata

Dear Sir/Madam,

Pursuant to Regulation 30 read with Regulation 30(13) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), we hereby inform you that the Company has received an Order from the Office of the Principal Commissioner of Customs (Port), Kolkata, in connection with the adjudication of Show Cause Notice No. KOL/CUS/PR.COMMR/PORT/GR.5/58/2025 dated September 08, 2025.

The proceedings relate to the availment of benefits under Sr. Nos. 485A and 490 of Notification No. 50/2017-Customs dated June 30, 2017, in respect of imports undertaken by the Company during the period from April 01, 2021 to December 31, 2022. Pursuant to the adjudication proceedings, the Customs Authority has, inter alia, held that the Company was not eligible for the aforesaid benefits and has consequently determined a liability towards differential customs duty and other consequential amounts under the Customs Act, 1962.

Accordingly, the Order directs the Company to pay differential customs duty of ₹76,90,665/- under Section 28(4) of the Customs Act, 1962, along with applicable interest under Section 28AA of the Customs Act, 1962. The Order further imposes a fine of ₹1,00,00,000/- in lieu of confiscation under Section 125 of the Customs Act, 1962. In addition, the Order imposes a penalty of ₹76,90,665/- under Section 114A of the Customs Act, 1962, with the statutory benefit of reduced penalty, subject to fulfilment of the prescribed conditions, including payment of the applicable duty and interest within the stipulated period. The Order also imposes a penalty of ₹50,00,000/- under Section 114AA of the Customs Act, 1962.

The aggregate amounts referred to above are subject to the outcome of the legal remedies available to the Company. The Company is presently evaluating the Order and intends to challenge the findings and directions contained therein before the competent appellate authority within the prescribed timelines. The Company will take all necessary steps to safeguard its interests and contest the matter in accordance with applicable law.

The Company would like to clarify that the receipt of the aforesaid Order does not represent a final determination of the matter from the Company's perspective, as the Company intends to exercise its statutory right of appeal. Accordingly, the ultimate financial impact, if any, will depend upon the outcome of the appellate/legal proceedings.

The Order, inter alia, denies/rejects the aforesaid benefits and directs payment of differential customs duty, applicable interest, fine and penalties as detailed hereinabove.

Expected financial implications on the listed company, if any	The Order has determined a differential customs duty liability of ₹76,90,665/-, along with applicable interest, a fine of ₹1,00,00,000/- in lieu of confiscation, penalty of ₹76,90,665/- under Section 114A and penalty of ₹50,00,000/- under Section 114AA of the Customs Act, 1962. The actual financial impact on the Company will depend upon the outcome of the appellate/legal proceedings and the extent of relief, if any, granted by the competent authority.

Details of any aberrations/non-compliances identified by the authority in the communication	The Customs Authority has, inter alia, held that the Company was not eligible for the benefits claimed under Sr. Nos. 485A and 490 of Notification No. 50/2017-Customs dated June 30, 2017, in respect of the relevant imports, resulting in demand of differential customs duty and consequential action under the Customs Act, 1962.
