Dear Members of the Board,

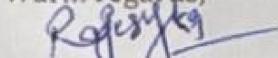
I hereby tender my resignation from the office of Independent Director of the Company, with effect from 15.01.2026, due to personal reasons and my preoccupations in other assignments.
