Pursuant to Regulation 30 of SEBI LODR & in furtherance to our letter(s) dated 19<sup>th</sup> March, 2025 & dated 24<sup>th</sup> March, 2025, the Company is in the receipt of interim stay order from Hon'ble Madras High Court.

The Hon'ble Madras High Court has specifically ordered "interim stay" on the debarment letter as issued by NHAI. Also stated clearly in the order that, the 3rd respondent i.e. NHAI (PIU) had issued the impugned debarment order, which is totally contrary to the reasons stated in the show cause notice.

The SEBI Circular having number SEBI/HO/CFD/CFD-PoD2/P/CIR/2025/25 dated February 25, 2025 is not applicable for the present disclosure.
