The impact on other activities, if any, will be evaluated and intimated accordingly. The Company shall explore all the possible recourse available with it, against the said letter/notice, including approaching before the appropriate forum/court, if required.

Upon examining the response, the NHAI has issued a debarment letter prohibiting the Consultants from participating in future bids for a period of 2 (Two) Years with effect from March 11, 2025. The Company was a silent partner in the said Project and the collaboration was merely on account of the technical expertise the Company possesses.
