1. 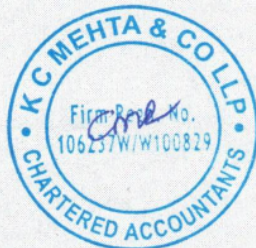

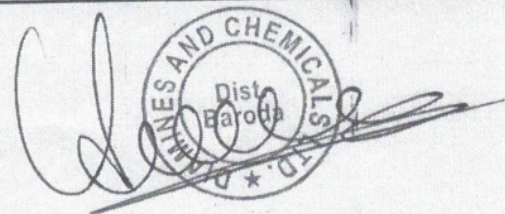

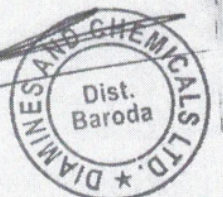
