Brief details of litigation viz. name(s) of the opposing party, court/ tribunal/agency where litigation is filed, brief details of dispute/litigation.	<p>Pursuant to the disclosure dated 06.05.2025, the parties managed to settle their disputes and Star Plastics agreed to pay a sum of INR 56,94,833/- (after adjustment of ad hoc payments of INR 10,00,000/-) to the Company, as a consequence whereof, the arbitration proceedings before ICA were closed. However, out of the agreed amount, only a sum of INR 2,50,000/- was received by the Company and Star Plastics failed to make the balance payment.</p> <p>In view of the breach of its obligations by Star Plastics, the Company has instituted a commercial suit for recovery against Star Plastics before the District Courts, New Delhi seeking recovery of INR 60,62,333/- (including penalty and interest).</p>
