This is with reference to the disclosure filed by the Company on August 30, 2024 regarding order passed by the Office of the Commissioner, Commercial Taxes Directorate of Commercial taxes, Government of West Bengal for a total GST demand amounting to Rs. 2,26,539 along with interest amounting to Rs. 2,78,654 and penalty amounting to Rs. 32,008.

Please note that the GOI had announced the GST Amnesty Scheme whereby on payment of the confirmed GST demand, the demand of Interest and Penalty would be waived.

We had preferred to opt for the GST Amnesty Scheme and in respect of this Order, we had paid the confirmed GST demand of Rs. 2,26,539 and accordingly the rest demand of Interest of Rs. 2,78,654 and Penalty of Rs. 32,008 have been waived. Further, the department has issued the order for conclusion of the proceedings.

As per the requirement of Regulation 30 of the Listing Regulations, read with SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, we wish to disclose the details of final order received by the Company as per **Annexure-A**.
