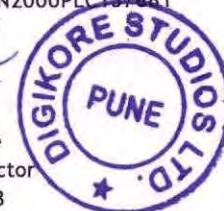

These restatements have been appropriately accounted for and disclosed by the management. Our audit opinion is not modified in respect of this matter.


