DRI'), Delhi</p> <p>Court/ tribunal/agency where litigation is filed: Hon'ble Supreme Court of India</p> <p>Brief details of dispute/litigation: This is with reference to the Company's intimations dated August 21, 2023 and October 6, 2025, wherein it was disclosed that the ADG (Adj.), DRI, Delhi, had, vide order dated April 28, 2020 ("Order"), confirmed a demand for differential duty amounting to Rs. 56.47 crore, along with applicable interest and an equivalent penalty.</p> <p>Subsequently, the Company filed an appeal before the Hon'ble CESTAT, Delhi, challenging the said Order. The Hon'ble CESTAT, by its order dated September 23, 2025, allowed the Company's appeal and set aside the impugned Order.</p> <p>Further, the Company has been informed today, i.e., March 18, 2026, that the ADG (Adj.), DRI, Delhi, has filed a Civil Appeal Petition before the Hon'ble Supreme Court of India against the aforesaid order passed by the CESTAT in favour of the Company.</p>
