Dear Sir/Madam,

This is with reference to your email dated June 26, 2025, highlighting certain discrepancies in the XBRL submission of the financial results of Dish TV India Limited for the quarter and year ended March 31, 2025, submitted on May 28, 2025.

In this regard, we would like to clarify the following:

1. Audited Tag for Quarter Ended March 2025:

The mention of “audited” in the XBRL file for the quarter ended March 31, 2025, was inadvertently selected. The same was intended for the full year ended March 31, 2025. This was a clerical oversight during the filing process.

2. Difference in Consolidated EPS:

It is to be noted that the EPS mentioned in the consolidated financial statements is correct. However, the EPS figure for the standalone financials in the "Year Ended" table has been incorrectly stated. This was an inadvertent error and the same will be rectified in the revised submission.

We deeply regret the oversight and confirm that necessary corrections will be made. We request you to kindly provide access or the necessary option to enable us to submit the revised and correct XBRL file at the earliest.
