In compliance with the aforesaid MCA and SEBI Circulars, applicable provisions of the Companies Act, 2013 and Rules made thereunder, and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, ("Listing Regulations"), and as confirmed by the Company, the Notice of the AGM along with the Annual Report 2025-26 was sent on August 08, 2026 through electronic mode to those Members whose e-mail addresses were registered with the Company, RTA or CDSL/NSDL ("Depositories") also intimation letter were send to those share holder whose mail Id's were not registered

- v) After the closure of the e-voting at the AGM, the votes cast through e-voting at the AGM and through remote e-voting prior to the date of AGM were unblocked on September 05, 2026, at 11: 19 a.m in the presence of two witnesses who are not in the employment of the Company.

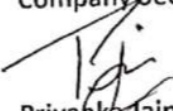

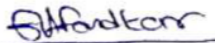
