COOPERATIVE BANKS ALLOWED DOORSTEP BANKING

Cooperatives should look at RBI differently: Shah

UNION MINISTER OF Cooperation
Amit Shah on Saturday urged urban cooperative banks (UCBs) to look at the RBI from a “different viewpoint,” underlining that the central bank has “proactively helped” the sector in recent times.

Speaking at the inauguration of a new office building of the National Urban Cooperative Finance and Development Corporation (NUCFDC) at the BSE in Mumbai, Shah also said that when it comes to the safety of money, no other segment is as safe for lenders as small borrowers.

“I know of your experience till now, RBI looks at you from a particular viewpoint, and UCBs also look at RBI from a different viewpoint. But we have to come out of it,” Shah told the audience comprising executives from over 1,400 UCBs and other stakeholders.

“My five years’ experience as the Union Cooperatives Minister suggests that whenever we have put a step forward with confidence, RBI has proactively helped us,” he added, listing out the relaxations delivered by RBI.

Among other aspects, RBI has liberalised branch opening, allowed UCBs to offer doorstep banking,

made it possible for them to issue demand drafts and life certificates, and also appointed a dedicated nodal officer just to look into the affairs of the UCBs, which have over ₹6 lakh crore of deposits, he said.

Shah, who also handles the Home portfolio, said a lot of aspects have been resolved with the help of the RBI, and also welcomed the raising of limits on gold loans and permitting one-time settlements for UCBs.

In a statement on developmental and regulatory policy accompanying the bi-monthly policy review announced on Wednesday, RBI Governor Sanjay Malhotra announced a move forward on the ‘on-tap’ licensing of UCBs, which will end a two-decades long pause in the matter.

In the past, instances of lax governance practices at UCBs, which are perceived to be controlled by political heavyweights, have led to instances of some lenders going down, leading to higher systemic caution.

Recalling his experience of chairing a UCB in Gujarat, Shah said the small borrower segment is the safest for lenders and pointed out a scheme of offering ₹2.5 lakh of loans without any collateral by his bank. He said the management had doubts, but the repayment rate including interest is over 99% under the scheme, and the overall lending offered has been doubled as well.

Shah also announced that NUCFDC, which works as an umbrella body for the sector, will soon be moving its head office to Maharashtra from New Delhi, and added that 449 of such lenders are in the state and 70% of the entities are from Maharashtra, Gujarat, Goa and Karnataka.

5% hike, pay parity among Bengal 7th panel’s terms

PAY PARITY WITH employees under Central Pay Commission, restoration of commuted pension after 11 years and raising annual increments from 3 to at least 5% are among the terms of reference of West Bengal’s seventh pay commission.

The panel constituted recently looks to propose a comprehensive revision of pay, allowances and service conditions of state government employees and changes in career progression, retirement and healthcare benefits.

It seeks to examine the existing



pay structure, allowances, pension, gratuity, and other retirement benefits, and to rationalise them in light of prevailing economic conditions and inflation.

A senior state government official said the proposals cover “all major aspects of the service conditions of government employees” and aim to address anomalies in the existing system.

“It is intended to bring greater rationalisation to the pay and service structure while taking into account present economic realities and the requirements of government employees,” the officer said.

Among the terms of reference of the seventh pay commission is to bring parity in the pay levels of state government employees and those under the Central Pay Com-

mission, to achieve all-India equivalence and reduce litigation arising from differences in pay structures.

The proposed terms of reference also seek to introduce a mechanism for dearness allowance based on the Consumer Price Index for Industrial Workers and recommend a standing order for its disbursement.

House rent and transport allowances are proposed to be reviewed in line with the Central Pay Commission, while children’s education allowance, hostel subsidy and other existing allowances are also to be examined for rationalisation and revision.

FSSAI warned Diageo over whisky’s ‘matured in American oak’ claim

FOOD SAFETY REGULATOR warned liquor giant Diageo that it misleadingly claimed one of its top-selling whiskies was “matured in American

oak casks,” when most of the product had not been matured, a confidential government notice shows.

The previously unreported July 20 notice from the Food Safety and Standards Authority of India (FSSAI), reviewed by *Reuters*, reveals another complaint by the regulator, in addition to an asser-

tion of improper flavouring that prompted the authorities to ban some spirits this month.

The FSSAI on August 2 announced it had prohibited sales of Diageo’s Royal Challenge Whisky made in Madhya Pradesh and some whisky and rum brands made by Diageo and Inbrev for using artificial flavouring, such as whisky and rum flavours, rather than proper ageing and ingredients.

The industry says it complies with the law.

The FSSAI did not respond to *Reuters* queries on the assertions about maturing.

Diageo India, the commonly used name for the local unit United Spirits, told *Reuters* on Saturday it remains committed to the highest quality standards and was “actively engaging with FSSAI to address their queries on labelling.”

The crackdown on the country’s \$40 billion alcohol industry, which has triggered some legal challenges, comes as the regulator increases its scrutiny of liquor companies, energy drink makers like PepsiCo and food producers over what it contends are incorrect labelling and weak compliance.

Waiting for report on Air India Phuket incident: Naidu

UNION MINISTER OF Civil Aviation

Ram Mohan Naidu Kinjarapu on Saturday provided an update following the severe air turbulence encountered by an Air India Phuket-Delhi flight on August 4, assuring the public that the situation is being handled with urgency and care.

Speaking on the medical status of those affected, the Minister noted that the majority of injured passengers were treated and released shortly after landing. “Most of the passengers were discharged from the hospital in the first few hours only,” Naidu stated.

Addressing the cause of the mid-air scare, Naidu confirmed that the Directorate General of Civil Aviation (DGCA) has stepped in to determine how the



incident occurred.

“As far as how the incident happened, the DGCA is investigating it, and we still have to know the final report on that. So we are waiting for that,” the Minister explained.

He further said that India is aiming to see electric air taxis take flight in the country by 2028, with testing of the emerging technology expected to gather pace next year.
