Notice is hereby given that pursuant to the provisions of the Section 124 (6) of the Companies Act, 2013 read with the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016 ('the Rules'), as amended from time to time, the Equity Shares of the Company (in respect of which the dividend (interim) declared during the FY 2018-19 has remained unclaimed or unpaid for a period of seven consecutive years) are required to be transferred by the Company to the demat account of the IEPF Authority.

In cases of shares held in Demat Form, to the extent shares liable to be transferred, the transfer would be effected by issuance of necessary instruction to the depository to transfer the shares directly to IEPF.

In the event of valid claim is not received on or before **August 20, 2025**, the Company will proceed to transfer the liable dividend and Equity shares in favor of IEPF authority without any further notice. Please note that no claim shall lie against the Company in respect of unclaimed dividend amount and shares transferred to IEPF pursuant to the said rules. It may be noted that the concerned shareholders can claim the shares and dividend from IEPF authority by making an application in the prescribed Form IEPF-5 online after obtaining Entitlement letter from the Company.
