13 Delhi seats see 40% deletion

New Delhi: Thirteen of Delhi's 70 assembly constituencies have witnessed the deletion of over 40% of their registered voters from draft electoral rolls prepared under Special Intensive Revision (SIR).

Tenants and migrant workers shifting houses have emerged as key factors behind this in the 13 seats: Tughlakabad (names of 47.8% voters deleted), Okhla (45.2%), RK Puram (44.4%), Kasturba Nagar (43.9%), Badli (42.7%), Badli Puri (42.5%), New Delhi (41.6%), Jangpura (41.4%), Mehrauli (41%), Patel Nagar (40.7%), Sangam Vihar (40.7%), Ka-

rol Bagh (40.4%) and Patparganj (40%).

The governing BJP said "every eligible voter" has been included on the draft rolls, while opposition AAP claimed booth-level officers (BLOs) in many places did not visit all voters and that the "entire SIR was a process of exclusion to strip the electors of their rights".

Southeast Delhi's Tughlak-

kabad, which has a mix of old village settlements, unauthorised neighbourhoods and dense lower- and middle-income neighbourhoods, reported the highest deletion rate in the city.

South Delhi MP Ramvir Singh Bidhuri said many migrant workers shifting base to Noida, Faridabad and Gurgaon was the main reason. "The people whose names have been deleted should get their names added to the rolls," he said.

Though the deletion rate in Burari was considerably lower at 39.4%, in absolute numbers, it recorded the highest deletion, with the names of 1,67,885 out of 4,28,490 registered electors missing from the

rolls as their enumeration forms were not submitted and thus couldn't be verified. Burari MLA Sanjeev Jha of AAP said his party had pointed out that BLOs had not reached several areas properly. "Election Commission's responsibility was to ensure that no citizen was deprived of their vote, but this entire process was meant to take away their right to vote," said Jha, demanding that those missing from the rolls be immediately provided complete information on how to take remedial action.

Sangam Vihar MLA Chandan Chaudhary of BJP said migration was a key reason for high rate of deletion, with many from Bihar not submitting enumeration forms.

Maha, Bengal list variations prove poll theft: Rahul

New Delhi: Citing huge variations in the pre and post-SIR voter lists, Congress leader Rahul Gandhi said the draft Mahabharata and the revised Bengal lists prove his allegation that elections in those states were stolen by the BJP.



Dubbing Election Commission as "vote chori commission", Rahul said EC and BJP were changing their tactics but their sole objective is "BJP's victory at any cost, and theft of democracy". Congress president Mallikarjun Kharge said EC included a large number of voters ahead of the assembly elections in Delhi, and has now dropped over 47 lakh voters from the draft list while preparing to send notices to over 30 lakh more. "Congress workers are facing manipulations daily in Telangana and Karnataka as well," he said.

Rahul said in Maharashtra, 39 lakh new voters were added between the Lok Sabha and Vidhan Sabha elections in 2019. "Now in Maharashtra, 2.7 crore voters have been removed from the draft list—that's every fifth voter: Lok Sabha 2024: 9.29 crore, Vidhan Sabha 2024: 9.7 crore, SIR 2026: 7.78 crore. Which list was correct?" he asked. Rahul said in Bengal, 91% of all names removed from the voters' list after SIR ahead of the 2026 assembly polls have been reinstated.

"That means 9 out of every 10 names were wrongly deleted, and added back only after the election. I said it then, and I say it today: This was vote theft," he said.

FIRs against Cong workers for rally, clash

Kolkata: Police have registered an FIR against several Congress workers following an "unauthorised rally" and subsequent clash with cops near Moula Crossing in central Kolkata on Aug 30, reports Dwaiyayan Ghosh.

The rally was in protest against the FIR on Rahul Gandhi over his remarks over a "purification" ritual at Haldwani's Ramliha Ground.

Police sources said the incident occurred around 6 pm on Monday when supporters organised a procession from the Bengal Pradesh Congress office on Lal Mohan Bhattacharjee Road and proceeded towards Moula.

The rally was in protest against the FIR on Rahul Gandhi over his remarks over a "purification" ritual at Haldwani's Ramliha Ground. When cops intercepted the rally at the intersection to maintain order, the crowd allegedly turned aggressive. Protesters began shouting slogans and attempted to burn an effigy of PM Narendra Modi.

The demonstrators, when stopped from setting the effigy ablaze, engaged in a heated altercation with on-duty personnel.

Police alleged that the group used criminal force to obstruct officers.
