The Company has received an intimation today from India Uniper Power Services Private Limited, (IUPSPL) a step down subsidiary of the Company informing that the Board of Directors of IUPSPL has approved the proposal of strike off of the Company from the register of Registrar of Companies, West Bengal, as per the provisions of the Companies Act, 2013 and Rules framed therein, subject to the necessary approval.

Pursuant to the above, IUPSP shall cease to be a step down subsidiary of the Company upon completion of the process of the voluntary strike-off.
