Dear Sir/Madam,

This is with reference to the Financial Results for the half year ended, 30th September, 2025 submitted by Divyadhan Recycling Industries Limited ("the Company"), a company listed on the SME Platform of the Exchange, on 13th November, 2025, pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with the applicable provisions for SME listed entities (half-yearly basis).

We have received the Exchange's query dated 20/01/2026 pointing out the following deficiencies in the said submission:

- 1. Financial results not signed by authorized signatories**
- 2. Machine Readable Form / Legible copy of Financial Results not submitted.**

We acknowledge that the financial results uploaded along with the Outcome of the Board Meeting were, inadvertently, (i) submitted without the signatures of the authorised signatories as required under Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and (ii) not provided in a fully machine-readable/searchable text format or were not sufficiently legible as per the Exchange's filing guidelines.

We had submitted a reply addressing the above deficiencies in 24 January 2026. However, we understand that resubmission alerts pertaining to the same deficiencies have continued to be generated.

To resolve the matter conclusively, we are re-submitting herewith a clear and legible copy of the financial results, duly signed by:

- Mr. Varun Gupta, Managing Director; and
- Mr. Pratik Gupta, Director.

We regret the inadvertent lapse and assure you that we have strengthened our internal review controls to prevent recurrence.

Independent Auditor's Review Report on the Half year ended Unaudited Standalone Financial Results of Divyadhan Recycling Industries Limited ("the Company") pursuant to the Regulations 33 and 52 of the SEBI (Listing Obligation and Disclosure Requirements) Regulation 2015, as amended

1. We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of **Divyadhan Recycling Industries Limited (Formerly Known as Divyadhan Recycling Industries Private Limited & Divyadhan Consultants Private Limited)** (the "Company"), for the Half year ended September 30, 2025 and year to date from April 1 2025 to september 30 2025. (the "Statement"), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
2. This Statement, which is the responsibility of the Company's Management and approved by the Company's Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in the Indian Accounting Standard 34 "Interim Financial Reporting" ("IND AS 34"), prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and other accounting principles generally accepted in India. 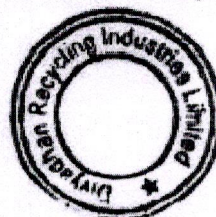

- The company is not having any subsidiary, associates or joint venture; therefore it has prepared only standalone results as consolidation requirement is not applicable to the company.

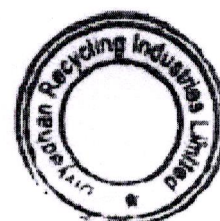
