**M&M gives in...**

In the strongly worded press statement, M&M added that it will challenge IndiGo's claim to keep what it called an 'unhealthy precedent' at bay. "We believe the claim by IndiGo is baseless and if not challenged, will set an unhealthy precedent of monopolising alphanumeric 2-character marks, despite our mark being distinctive and different. This will be enormously constraining for all companies across industries and sectors," the statement said. The case, which came up for hearing on Tuesday, is now scheduled to be heard on December 9.

M&M also reminded IndiGo of its previous conduct, citing the example of Tata Motors' sedan named Indigo. "We would like to point out that in the past, Tata Motors had objected to InterGlobe using the IndiGo mark, given their Tata Indigo car brand. InterGlobe continues to use the mark IndiGo in a different industry and business. We, therefore, find their objection to BE 6e to be inconsistent with their own previous conduct," the M&M statement added. The '6E' of IndiGo is the unique code allotted to it by the International Air Transport Association (IATA), a trade association of world's airlines. IndiGo's flights are defined by this code followed by the flight number.

While Mahindra has applied for trademark registration under class 12 (vehicles) for "BE 6e" as a part of its electric origin SUV portfolio, IndiGo had claimed that the "6E" mark has been an integral part of IndiGo's identity for the past 18 years and is a registered trademark. "Any unauthorised use of the '6E' mark, whether standalone or in any form, constitutes

an infringement of IndiGo's rights, reputation, and goodwill. IndiGo is committed to taking all necessary and appropriate steps to safeguard its intellectual property and brand identity," an IndiGo spokesperson had said on Tuesday.

**RBI governor...**

Das took charge with a conciliatory yet firm approach, emphasising the RBI's autonomy while maintaining open lines of communication with the government. One of Das's defining challenges was the economic crisis triggered by the Covid pandemic. नवी दिल्ली, दि. ७ (वृत्तसंस्था) : अमेरिकेत गेल्या महिन्यात झालेल्या अध्यक्षीय निवडणुकीत माजी अध्यक्ष डोनाल्ड ट्रम्प यांनी विजय मिळवत दमदार पुनरागमन केले आहे. या निवडणुकीच्या दरम्यान डोनाल्ड ट्रम्प यांच्यासाठी उद्योगपती एलॉन मस्क यांनी त्रोरदार प्रचार केल्याचे पाहायला मिळाले. एलॉन मस्क यांनी ट्रम्प यांच्या विजयासाठी फक्त प्रचारच केला नाही, तर त्यांच्या विजयासाठी मस्कनी २२०० कोटी रुपये खर्च केले आहेत.

ट्रम्प यांच्यासाठी २२०० कोटी खर्च

२०० दशलक्ष डॉलर्स देणगी या व्यतिरिक्त एलॉन मस्क यांनी RBG PAC या संस्थेलाही २० दशलक्ष डॉलर्स इतकी देणगी दिली होती. या संस्थेने गर्भपाताबाबत डोनाल्ड ट्रम्प यांची प्रतिमा प्रतिमा बदलण्यासाठी काम केले होते. वॉशिंग्टन पोस्टने दिलेल्या वृत्तानुसार मस्क यांनी दिलेल्या या देणगीनंतर त्यांनी टिम मेलन यांना मागे टाकले आहे. त्यांनी ट्रम्प यांना २०० दशलक्ष डॉलर्स इतकी देणगी दिली होती.

'लवकरात लवकर तिथून निघा' सीरियामधील भारतीय नागरिकांना परराष्ट्र मंत्रालयाचे आवाहन

नवी दिल्ली, दि. ७ (वृत्तसंस्था) : सीरियामध्ये अंतर्गत तणाव वाढल्यानंतर आता भारत सरकारने सावधगिरीचे उपाय योजले आहेत. परराष्ट्र मंत्रालयाने मार्गदर्शक सूचना दिल्या असून भारतीय नागरिकांना सतर्क राहण्यास सांगितले आहे. सीरियातील दुसरे सर्वात मोठे शहर असलेल्या अलेपो शहरावर जिहादी सैनिकांनी ताबा मिळवला आहे. आता हे जिहादी सीरियाची राजधानी दमास्कसकडे वळले असल्याची माहिती समोर येत आहे. या पाश्चिमीवर भारतीय नागरिकांनी सीरियात प्रवास करणे टाळावे, असे परराष्ट्र मंत्रालयाने शुक्रवारी रात्री सांगितले. तसेच सीरियात असलेल्या भारतीय नागरिकांनाही लवकरात लवकर सीरिया सोडण्याचे आदेश देण्यात आले आहेत.

परराष्ट्र मंत्रालयाने काय सांगितले ?

परराष्ट्र मंत्रालयाने प्रसिद्ध केलेल्या निवेदनात म्हटले की, सीरियातील विद्यमान परिस्थिती पाहता भारतीय नागरिकांनी पुढील सूचना मिळोपर्यंत सीरियातील प्रवास टाळावा. तसेच सध्या सीरियात असलेल्या भारतीय नागरिकांनी दमास्कसमधील भारतीय उच्चायुक्तालयाशी संपर्क साधावा यासाठी +९६३ ९९३३८५९७३ या क्रमांकावर आणि hoc.ducul.com/sea.gov.in या ईमेल आवडीवर संपर्क साधावा, असा सूचना दिल्या आहेत. परराष्ट्र खात्याचे प्रवक्तें रणधीर जैवाल हे सीरियामधील परिस्थितीवर बारकाईने लक्ष ठेवून आहेत. त्यांनी सांगितले, "सीरियाच्या उत्तरेकडे निर्माण झालेल्या तणावाची आम्ही दखल घेतली आहे. त्यावर आमचे बारीक लक्ष आहे. सीरियात जवळपास १० भारतीय नागरिक आहेत. ज्यापैकी १४ जण संयुक्त राष्ट्रांच्या विविध संघटनांसाठी काम करत आहेत." नागरिकांच्या सुरक्षेला आमचे सर्वोच्च प्राधान्य असेल.

सीरियामध्ये मागच्या दोन आठवड्यांपासून पुन्हा एकदा जुना संघर्ष पेटला आहे. २०११ मध्येही अशाच प्रकारची परिस्थिती निर्माण झाली होती. ज्यामुळे सीरियात लाखो लोक मारले गेले होते आणि तेवढेच लोक बेघर झाले होते. सिरियाचे अध्यक्ष बशर अल असद यांच्या सरकारला उलथून लावण्यासाठी काही बंडखोर गटांनी सशस्त्र उठाव सुरू केला आहे. २०११ सालीही अशाच प्रकारचा उठाव केला गेला होता, मात्र त्यावेळी हा प्रयत्न हाणून पाडण्यात आला होता.

वर्गातील मुलाला मुस्लिम विद्यार्थ्यांच्या कानाखाली मारायला सांगणाऱ्या शिक्षिकेला न्यायालयाकडून जामीन

नवी दिल्ली, दि. ७ (वृत्तसंस्था) : उत्तर प्रदेशातील मुझफ्फरनगर न्यायालयाने, वर्गातील मुलाला शिक्षा म्हणून मुस्लिम विद्यार्थ्यांच्या कानाखाली मारायला सांगणाऱ्या शिक्षिकेला जामीन मंजूर केला आहे. वार अॅड बॅचने याबाबत वृत्त दिले आहे. या प्रकरणाची सुनावणी करताना विशेष न्यायालयाच्या न्यायमूर्ती अलका भारती म्हणाल्या की, "या प्रकरणातील आरोपी शिक्षिकेवर पूर्वीच आरोपपत्र दाखल करण्यात आले आहे. तसेच या प्रकरणाच्या तपासादरम्यान आरोपीला अटक करण्यात आली नव्हती. आरोपी शिक्षिका ६१ वर्षाची असून, तिला ४० टक्के अपंगत्व आहे." या शिक्षिकेवर आरोप केलेल्या गुन्हासाठी किमान सात वर्षांच्या तुरुंगवासाची शिक्षा असल्याचेही न्यायालयाने यावेळी नमूद केले.

या प्रकरणातील आरोपी शिक्षिकेच्या वकिलाने विशेष न्यायाधीशांसमोर असा युक्तिवाद केला की, "आरोपी शिक्षिकेविरुद्धचा प्रथम माहिती अहवाल या प्रकरणाला जातीय कोण देण्यासाठी दाखल करण्यात आला होता. या शिक्षिकेने असे कोणतेही कृत्य केलेले नाही, ज्यामुळे समाजामध्ये वैमनस्य निर्माण होईल किंवा समाजाला हानी पोहोचेल."

या प्रकरणात आरोपी शिक्षिकेला अटकपूर्व जामीन देण्यास अलाहबाद उच्च न्यायालयाने नकार दिला होता. न्यायालयाने या शिक्षिकेला दोन आठवड्यांच्या आत संबन्धित न्यायालयासमोर आत्मसमर्पण करण्याचे निर्देश दिले होते. त्यावेळी न्यायालयाने आपल्या निर्देशात म्हटले होते की, दोन आठवडे किंवा कनिष्ठ न्यायालयासमोर शरण येईपर्यंत आरोपीवर कोणतीही कारवाई करू नये.

देशात परदेशी चलनाचा ओघ वाढवण्यासाठी रिझर्व्ह बँकेने परदेशी चलनातील ठेवींवरील व्याजदर मर्यादा वाढवण्याची शुक्रवारी घोषणा केली. अमेरिकी डॉलरच्या तुलनेत रुपयाला सावण्यासाठी हे पाऊल उचलले गेले आहे. मध्यवर्ती बँकेने शुक्रवारपासून, बँकांना आता १ वर्ष ते ३ वर्षांपेक्षा कमी मुदतीच्या परदेशस्थ भारतीयांच्या नवीन ठेवींवरील व्याजदर वाढवण्याची परवानगी दिली. ती वाढीव व्याजदर मर्यादा 'ओव्हरनाइट अल्टरनेटिव्ह रेफरन्स रेट' (एआरआर) अधिक ४०० आधारबिंदू अशी असेल. ती याआधी २५० आधारबिंदू एवढी मर्यादित होती. त्याचप्रमाणे, ३ ते ५ वर्षांच्या मुदतीच्या ठेवींवर एआरआर अधिक ५०० आधारबिंदू व्याज दिले जाऊ



शकते. पूर्वी त्यासाठी ३५० आधारबिंदूची कमाल मर्यादा होती, अशी माहिती रिझर्व्ह बँकेचे गव्हर्नर शक्तिकांत दास यांनी दिली. पुढील वर्षी ३१ मार्चपर्यंतच या व्याजदर मर्यादा लागू घेता येईल, असे त्यांनी सांगितले.

पाऊल डॉलरच्या तुलनेत रुपया ऐतिहासिक नीचांकी पातळीवर पोहोचला असून विनिमय मूल्यातील अस्थिरता रोखण्यासाठी मध्यवर्ती बँकेकडून डॉलरची विक्री सुरू आहे. परिणामी परकीय चलन
