I, Gouri Shankar Mishra, Partner, BGSMISHRA & Associates, Company Secretaries LLP had been appointed as the Scrutinizer by the Board of Directors of Destiny Logistics & Infra Limited (the Company) pursuant to Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended to scrutinize the resolutions approved by the members of the Company by means of Postal Ballot and e-Voting, conducted from Thursday, 29<sup>th</sup> January 2026 at 9.00 A.M.
