Sub: - Outcome of the meeting held today i.e., September 14, 2024, in respect of Conversion of Equity Share warrants (“warrants”) into Equity Shares

This is to inform you that pursuant to the approval of Shareholders in their Annual General Meeting held on September 21, 2023, the Board of the Directors of the Company (the “Board”) had in their meetings held on October 06, 2023, October 07, 2023, October 09, 2023, October 10, 2023 and October 11, 2023, allotted convertible equity share warrants (“warrants”) on preferential basis to promoters and non-promoters.

Further, we wish to inform you that the Board in its meeting held today, i.e., on September 14, 2024, considered and approved the conversion of 10,01,112 (Ten Lakh One Thousand One Hundred Twelve) warrants into 10,01,112 (Ten Lakh One Thousand One Hundred Twelve) equity shares of face value of ₹ 10/- each, upon receipt of an amount aggregating to ₹ 4,50,50,040/- (being the balance 75% of the issue price per warrant) from the allottees (mentioned in *Annexure – I*) pursuant to the exercise of their right of conversion into equity shares in accordance with the Special resolution of the members dated September 21, 2023 and the provisions of the Companies Act, 2013 and the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018.

Consequent to aforementioned conversion of warrants and allotment of Equity Shares, 3,00,000 warrants of Promoters and 9,00,000 warrants of non-promoters (public) remain pending for conversion.

Pursuant to the conversion, the Issued, Subscribed and Paid-up Equity Share Capital of the Company stands increased to ₹ 22,31,81,920/- (Rupees Twenty Two Crore Thirty one Lakh Eighty One Thousand and Nine Hundred Twenty only) consisting of 2,23,18,192 (Two Crore Twenty Three Lakh Eighteen Thousand One Hundred and Ninety Two) fully paid-up Equity Shares of ₹ 10/- each. The new equity shares so allotted shall rank pari-passu with the existing equity shares of the Company.
