SUMMARY OF PROCEEDINGS OF THE 9TH ANNUAL GENERAL MEETING (“AGM”) OF DYNAMIC SERVICES & SECURITY LIMITED HELD ON FRIDAY, 26TH SEPTEMBER 2025 THROUGH VIDEO CONFERENCING (“VC”)/ OTHER AUDIO-VISUAL MEANS (“OAVM”)

The 9th Annual General Meeting (“AGM”) of the Members of the Company was held today i.e., **Friday, September 26, 2025** through Video Conferencing (“VC”) / Other Audio-Visual Means (“OAVM”) deemed to be held at the Registered office of the Company at 375, Dakshindari Road, Kolkata–700048, in compliance with the applicable provisions of the Companies Act, 2013 and the relevant Circulars issued by the Ministry of Corporate Affairs and the Securities and Exchange Board of India.

The AGM commenced at 1:00 p.m. IST and concluded at 1:20 p.m. IST (excluding the time allowed for e-Voting during the AGM).

Ms. Karishma Sharma, Company Secretary & Compliance Officer of the Company welcomed the members and informed that Meeting was held through VC/ OAVM in compliance with the circulars issued by the Ministry of Corporate Affairs (MCA) and the Securities and Exchange Board of India (SEBI), and in accordance with the Companies Act and SEBI (LODR) provisions.

She further stated that proceedings of the meeting are considered to be conducted at the Registered Office of the Company, even though participation is virtual.

Mr. Jugal Kishore Bhagat, Managing Director of the Company chaired the meeting. On confirming that the requisite quorum was present through VC, he welcomed all the members, Directors, and other participants to the AGM.

As per the records of attendance, 61 participants attended the meeting. As the AGM was held through VC/OAVM, the facility for appointment of proxies by the members was not available.

After ascertaining from the Company Secretary & Compliance Officer that the requisite quorum was present at the AGM, the Chairperson called the Meeting to order and commenced the proceedings of the meeting at 1:00 PM.

Mr. Jugal Kishore Bhagat, took the chair and presided over the meeting. He extended a warm welcome to all the members attending the Meeting through VC/OAVM and started the formal proceedings.

He then briefed the shareholders about the company’s business and future outlook of the Company. He briefed about the growth in revenue of the company compared to the previous year. He further stated that company has been providing Manpower, housekeeping and various other services to various government and semi- government organisation and providing a future outlook for further growth.

The chairperson then concluded his speech stating that the resolutions proposed in the Notice of the meeting shall be deemed to have been proposed and seconded due to earlier remote e-voting on the date of AGM, subject to the requisite number of votes being received and handed over the proceedings to Company Secretary Ms. Karishma Sharma.

The Company Secretary & Compliance Officer informed that the statutory registers under the Companies Act, 2013 and the other documents as referred in the AGM Notice were available for inspection by the members at the Registered Office of the Company.

She further introduced the Board Members, Chairperson of the Audit Committee, Nomination and Remuneration Committee, Stakeholders Relationship Committee and Key Managerial Personnel, who was present to answer the queries of shareholders.

She further informed that Mr. Bijan Ghosh, Proprietor of Bijan Ghosh & Associates, Chartered Accountants, Statutory Auditor of the Company and Mr. Gouri Shanker Mishra, Partner of BGSMISHRA & Associates, Company Secretaries LLP, Scrutinizer for the AGM was also present at the meeting.

The remote e-voting was kept open from Tuesday, 23rd September 2025 at 9:00 A.M. and ended on Thursday, 25th September 2025 at 5:00 P.M. Members were informed that e-voting was also made available during the meeting for the members who did not cast their vote prior to the meeting. She further informed that the Company had engaged the services of CDSL as the authorised agency to provide the e-voting facility and Mr. Gouri Shanker Mishra, Partner, BGSMISHRA & Associates, Company Secretaries LLP was appointed as the scrutinizer for independently scrutinizing the e-voting process in a fair and transparent manner.

She further informed that the notice and audited accounts with auditor's report were already circulated and with the consent of members, the Notice convening the AGM, the Boards' Report and the Auditor's Report for the financial year ended March 31, 2025, were taken as read.

The Auditors Report and the Secretarial Audit Report for the financial year ended March 31, 2025 were also taken as read along with the observations in the Secretarial Auditors' Report. She further read the observations in the Secretarial Auditors' Report. The observations were explained.

The company secretary further informed the panel that there were no members who had registered themselves as speakers to express their views. Further no questions received from the shareholders present at the meeting.

Thereafter, she proceeded with the business transacted at the meeting as per the Notice convening the 9th AGM of the Company dated 2nd September 2025:
