Since then, GIC has sold equity shares of the TC in multiple non-reportable (by GIC to the stock exchanges) tranches and, on 30 July 2026 GIC had in aggregate sold such number of equity shares of the TC that the disclosure requirement under Regulation 29(2) of the SEBI Takeover Regulations was triggered with respect to the change in shareholding of GIC in the TC and accordingly the present disclosure under Regulation 29(2) of the SEBI Takeover Regulations is being made.
