Further, pursuant to execution of Business Transfer Agreement, there was transfer of Portfolio Management Services ('PMS') Business from WO Capital to WhiteOak Capital Asset Management Limited with effect from **April 01, 2024**. Hence, the revised threshold in WO Capital post transfer of PMS business (**0.93%**) stood at **4.81%** and accordingly, the aforesaid reporting is done as per Regulation 29(2) of SEBI (SAST) Regulations, 2011.
