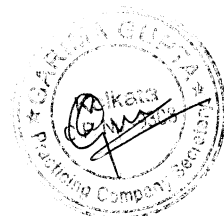

I, Garima Gupta, Company Secretary in Practice (Membership No.A23738 and CP No.9308) having my office at 5D Heysham Road, Kolkata 700020, have been appointed as a Scrutinizer of Eastern Silk Industries Limited (CIN:L17226WB1946PLC013554) having its Registered Office at 19, R.N.
