Rajasthan HC grants six-month bail to rape convict Asaram on medical grounds

JAIPUR : The Rajasthan High Court in Jodhpur on Wednesday granted six months' bail to self-styled godman Asaram, who is serving a life sentence for the rape of a minor.

A division bench comprising Acting Chief Justice Sanjeev Prakash Sharma and Justice Sangita Sharma heard Asaram's plea for suspension of sentence and bail on medical grounds.

The petition was filed earlier this month, citing his deteriorating health. Senior advocate Devdutt Kamat, appearing from Delhi, represented Asaram, while Additional Advocate General



Deepak Chaudhary argued for the Rajasthan government. Advocate P.C. Solanki represented the victim. After hearing all sides, the bench

granted him bail for six months.

Following the High Court's latest order, Asaram will remain out of jail for six

months. He is expected to continue medical treatment under judicial conditions until further review by the court. Asaram, convicted of raping a minor girl in 2018, has been in jail for nearly 12 years. He was granted interim bail for the first time on January 7, 2025, also on medical grounds. He surrendered on August 30, 2025, after the expiry of that interim bail period.

During his medical treatment, he was seen greeting devotees from a hospital window, an incident that sparked renewed debate over his privileges while under custody.

Earlier, on August 27, a division bench of Justice Dinesh Mehta and Justice Vineet Kumar Mathur had rejected Asaram's plea to extend his interim bail.

The court relied on the medical report from the Ahmedabad Government Hospital, which concluded that, "Asaram's health condition is stable and he does not require hospitalisation or continuous medical care." The bench also noted that Asaram had travelled to multiple hospitals over the preceding months but had not maintained regular follow-up treatment at any single facility.

'India a natural maritime power': Italy's envoy hails PM Modi's vision

NEW DELHI : Ambassador of Italy to India Antonio Enrico Bartoli on Wednesday lauded Prime Minister Narendra Modi's commitment to developing India's maritime sector, describing his vision as "strong, clear, and transformative."

Speaking to IANS on the sidelines of India Maritime Week 2025 in Mumbai, the envoy said that since 2016, Prime Minister Modi has consistently positioned India as a major player in the global maritime industry. "Over the past decade, India has witnessed a remarkable transformation. The development of new ports, expansion of coastal trade activities, and strengthening of logistics networks have made the transportation system more efficient and

reliable," he said. Bartoli noted that improved rail connectivity to industrial hubs like steel, fertiliser, and mining sectors has enhanced India's trade capacity and cargo movement, earning global trust and attention.

"The Prime Minister's vision for 2047 aims to establish India as a global maritime hub through technological innovation and economic growth. These initiatives reflect India's journey toward self-reliance and sustainable maritime development," he added. Praising Modi's leadership, the Italian Ambassador said, "PM Modi has a great vision and he demonstrates this in every sector. Vision is made of objectives and precise benchmarks, and while encourag-

ing India to reach those benchmarks, he also achieves results."

Calling India a "peninsula in the Indian Ocean," Bartoli said it is natural for the country to harness its geographic advantage and emerge as a maritime power. "Making India one of the top five global shipbuilding nations by 2047 is very understandable and feasible. We are interested in collaborating with India in this sector, bringing our expertise to support the effort," he stated. On India-Italy relations, Bartoli said there is an "ocean of opportunities" in the maritime domain as both nations have established a strategic partnership. "Our prime ministers have identified ten areas of collaboration, one,

Mizoram: MNF stages shutdown protesting new forest law



AIZAWL : The Mizo National Front (MNF), Mizoram's main opposition party, on Wednesday observed a 10-hour statewide shutdown protesting the Forest Conservation (Amendment) Act (FCAA), 2023, enacted by the Centre.

The Mizoram assembly during its recent monsoon session in August adopted a fresh resolution to extend the FCAA, 2023, to the state with effect from this year, following a motion introduced by Environment, Forests and Climate Change Minister Lalthansanga. The shutdown, which began at 6 am, was observed across the state except in the Mamit district in view of the November 11 by-election to the Dampa assembly seat. MNF Vice-President and Leader of Opposition Lalthandama Ralte said that the shutdown was total and successful.

"Immediately after its passage in Parliament, the then MNF government passed an official resolution opposing the Act in August 2023. During that time, the Zoram People's Movement (ZPM) led by Lalduhoma, then sitting in the opposition bench, had also vehemently opposed the FCAA 2023, terming it an attempt by the Central government to undermine the special constitutional protections of Mizoram under Article 371(G)," the statement said.

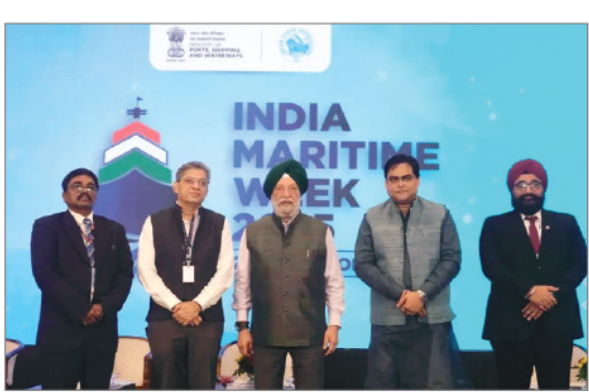
The ZPM now rules the Northeastern state. It said that Article 371(G) of the Constitution clearly provides that no Act of Parliament in respect of ownership and transfer of land shall apply to the state of Mizoram unless the Legislative Assembly of the state of Mizoram by a resolution so decides.

J&K govt plans modernisation of irrigation in Sonawari & multiple schemes to tackle drinking water shortages in Srinagar

SRINAGAR : The J&K government plans modernisation of irrigation schemes in Sonawari constituency of Bandipora district & multiple water supply schemes to tackle drinking water shortages in Srinagar city, the Assembly was informed on Wednesday.

The government has announced a comprehensive plan to augment and modernise the existing irrigation-cum-dewatering schemes in the Sonawari constituency, ensuring better irrigation facilities for thousands of households dependent on agriculture.

According to a written reply tabled in the house by the Jal Shakti Department in response to a question by MLA Hilal Akbar Lone, there exists a vast irrigation network of 112 canals in Sonawari, covering approximately 245 km of main canals and 90 km of distributaries. This network benefits nearly 20,625 households and covers a command area of 21,416 acres. The department said that four schemes have already been completed under the Accelerated



Irrigation Benefit Programme (AIBP) and District Capex funds. Additionally, 21 works have been executed in the last five years through the PRI, DDC, and Capex grants to strengthen the irrigation infrastructure under the IFC Division Sumbal.

Moreover, eight Detailed Project Reports (DPRs) have been prepared under NABARD and the Pradhan Mantri Jan Vikas Karyakram (PMJKY) for further modernisation and augmentation of irrigation schemes in Sonawari. A key project, "Construction of LIS Odina," has been proposed under RIDF-XXI (NABARD), to be

executed in two stages. The project aims to lift water from the River Jhelum and discharge it into Nallah Amir Khan, benefiting several villages and boosting agricultural productivity.

Officials said these initiatives are aimed at promoting agricultural development and ensuring smooth irrigation facilities for farming communities across Sonawari.

The J&K Government also informed the Assembly that several measures are being implemented to improve the water supply scenario in Srinagar district. Responding to a question by MLA Tariq Hameed

Kara, the Housing and Urban Development Department said that new water supply schemes are under execution to address the growing water scarcity in the city.

According to the reply, various initiatives include the construction of overhead tanks at multiple locations, laying of new pipelines, and the augmentation of the existing water supply network. The government is also focusing on upgrading water treatment plants to ensure a clean and adequate water supply to residents. Under the centrally sponsored AMRUT 2.0 programme, 18 projects - including four specifically in Central Shalteng constituency - have been sanctioned to enhance the water supply infrastructure across Srinagar.

The department further stated that old and damaged pipelines are being regularly replaced as part of a proactive approach to modernise the city's water network.

Officials emphasised that these efforts aim to ensure an uninterrupted and safe water supply to all households in the Srinagar district.

Azharuddin likely to be included in Telangana Cabinet



HYDERABAD : Former Indian cricket captain Mohammed Azharuddin is likely to be inducted into the Telangana Cabinet.

He is likely to be sworn in as the minister on Friday (October 31), Congress sources said.

The ruling party has been at the receiving end from various sections of the community for not having a single Muslim minister ever since it came to power nearly two years ago.

All key Muslim candidates of the Congress party, including Azharuddin, had suffered defeat in the 2023 Assembly elections.

After the defeat in the 2023 elections from his home

constituency, Jubilee Hills, he was keen to re-enter the fray after the seat fell vacant following the death of sitting MLA Maganti Gopinath of the Bharat Rashtra Samithi (BRS).

However, the party leadership persuaded him to accept the nomination as MLC with the assurance of a Cabinet berth.

The induction of the 62-year-old is also expected to

help the Congress party reach out to Muslims, who constitute about 30 per cent of the electorate in Jubilee Hills.

During the election campaign, the BRS had been targeting the Congress party for what it called 'deceiving' the Muslim community and also 'betraying' Azharuddin.

The Cabinet was formed on December 7, 2023, with the swearing-in.

Under BAPS' 'Mission Rajipo', over 40,000 children transform Sanskrit into sanskar

NEW DELHI : In an age when digital technology is taking away the peace of mind, the BAPS spiritual guru Mahant Swami Maharaj's divine vision has ignited a global awakening.

The "Mission Rajipo", helmed by BAPS Swaminarayan Sanstha, has illuminated a new path - one where spiritual learning and character formation walk hand in hand.

A year ago, Mahant Swami Maharaj envisioned children learning and reciting Sanskrit verses across the world. Describing Sanskrit as the mother of all languages, he said that those who absorb and live by the verses of Sanskrit will not only grow spiritually but will also excel in every field of life. Setting a divine goal, Mahant Swami Maharaj inspired that within one year, 10,000 children should learn the Sanskrit shlokas by heart. The inspiration began as a divine goal but soon became a movement - over 40,000 children have enthusiastically registered to participate. Among them, 15,666 boys and girls successfully memorised all 315 Sanskrit verses.

This comes two months after the State Cabinet nominated him as a Member of the Legislative Council (MLC) under the Governor's quota.

The move to nominate him as MLC had baffled all, as Azharuddin had declared himself as the Congress candidate for the by-election to the Jubilee Hills Assembly constituency.

However, Azharuddin's reaction to the Cabinet decision hinted that the party leadership had given him the assurance to elevate him as a minister.

The former MP had stated that he was 'deeply honoured and humbled' by the Cabinet's decision, and while thanking the leadership, he gave an assurance that he 'remains committed to serving the State with integrity and dedication'.

The Congress party recently announced Naveen Yadav as its candidate for the by-election scheduled on November 11.

Azharuddin's induction into the Cabinet will finally give representation to the Muslim community.
