Subject: Intimation pursuant to Regulation 30 of the SEBI (Listing and Disclosure Requirements) Regulation, 2015- Re-bidding of the Company.

Dear Sir/Madam,

Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we have been informed by our Lawyer vide their email dated March 15, 2026, at 19:03 hrs, who appeared before the NCLT on the hearing held on March 13, 2026 that the NCLT inter-alia has **directed issuance of fresh Form G with a further direction that the CIRP be concluded within 100 days.**

Further, the NCLT also directed the Insolvency and Bankruptcy Board of India (IBBI) to initiate an investigation into the SRA's failure to implement the approval of the Resolution Plan. It was further directed that upon completion of such investigation, if offences are made out, IBBI shall file a complaint under Section 236 of the Insolvency and Bankruptcy Code, 2016.

The brief details of the disposal of various other IA are as follows:

- Contempt Petition 55/2023 filed by the ERP regarding wilful disobedience of orders dated 07.08.2023 and 29.08.2023 by the SRA.
- IA/57/2023 filed by SBI under Regulation 39(9) of the CIRP Regulations for implementation of the approved Resolution Plan.
- Contempt Petition 11/ND/2025 filed by IDBI Bank seeking initiation of contempt proceedings against the SRA.
- IA-1766/ND/2025 filed by the ERP seeking directions for execution of the Resolution Plan approval dated 09.10.2023 under Section 424 of the Companies Act, 2013.
- In IA-2952/ND/2024 filed by Mr. Shantanu Prakash ex-promoter, seeking de-freezing of his shareholding, and the connected IA-5266/ND/2025 (seeking to place additional documents on record). The Tribunal disposed of both applications with liberty to Mr. Prakash to make an appropriate representative before the Resolution Professional of the Corporate Debtor.
