Pursuant to Regulation 27 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("LODR Regulations"). Please find enclosed herewith an Integrated Corporate Governance report in PDF format.

The Corporate Governance report in XBRL format is also being filed.

Further, there is no incidence of cyber security breach or incidence of loss of data during the quarter.

As informed earlier also vide various communications, NCLT had ordered the commencement of CIRP in respect of the Company under the provisions of IBC. Therefore, in accordance with Section 17 & 18 of the Code, the powers of the Board stood suspended and Dr. Sanjeev Aggarwal was appointed as interim resolution professional of the Company. The IRP carried out his duties from May 30, 2017 till Mr. Mahender Khandelwal was appointed as Resolution Professional (RP) vide the order of NCLT dated September 12, 2017 and took over the management of the affairs of the Company. On 9th October, 2023 the resolution plan is approved by the NCLT which is yet to implemented. Thereafter, on November 23, 2023 the NCLT has ordered that the RP would act as caretaker qua the CD and in such capacity, he would discharge all those functions as are required to be discharged by an IP as RP. In view of the suspension of the board as explained above, there is no question of having composition of board, committee of the board and applicability of Corporate Governance and other requirements.
