Subject: Clarification for Financial results - EIFFL

Respected Sir/Madam,

This is with reference to your email dated **13th January, 2026** regarding discrepancies in the financial results submitted in XBRL, wherein **quarterly figures were not provided**.

In this regard, we would like to submit the following clarification:

While filing the financial results, the Company inadvertently selected the option under **General Info - Reporting Type and Reporting Quarter as "Half Yearly"**, due to which the appropriate fields for entering quarterly data were not displayed in the XBRL utility.

Subsequently, the Company received a **guidance email from NSE dated 28th November**, wherein it was clarified that, as per **Regulation 33 of SEBI (LODR) Regulations, 2015**, entities listed on the Main Board are required to submit **quarterly financial results**, and that certain listed entities had selected the Reporting Type and Reporting Quarter as Half Yearly in the Integrated Filing - Financials (XBRL) for September 2025. The said guidance advised entities to revise the filing by selecting **Reporting Type as "Quarterly" and Reporting Quarter as "Second Quarter"** (or as applicable) through the prescribed path.

Pursuant to the above guidance, the Company **revised the filing on priority on the same date**, and duly submitted the quarterly as well as year-to-date figures to NSE through the NEAPS portal, bearing **NEAPS Application No. 129709**.

We further submit that the error was purely inadvertent and procedural in nature. There was **no mala fide intention or intent to mislead or deceive any stakeholder**. The Company firmly believes in transparency and has not concealed any material information intentionally.

We request you to kindly take the above clarification on record.
