Hence, we are unable to comment on the increase in volume of the Company's security across Exchanges in the recent past and the Company is in no way connected with any such price/volume movement.

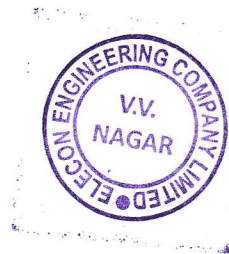

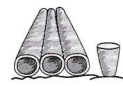
