**Subject: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") - Incident of fire at our manufacturing plant located at Hinjawadi, Pune, Maharashtra.**

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform you that today, i.e., February 07, 2026, there was an incident of fire at the utility block of our manufacturing plant (*Plant I*) located at Hinjawadi, Pune, Maharashtra.

The reason of the fire is yet to be ascertained. The fire was controlled but the operation of the said manufacturing plant is temporarily disrupted for an estimated period of 5 to 7 days. There are no human injuries or casualties reported. The Company is taking all necessary and adequate measures to restore the operations of the said plant at the earliest. There is adequate insurance coverage for aforesaid plant and intimation to the Insurance Company has already been made.

Any further development related to this incident will be intimated within due time.
