Sub: Clarification in Response to NSE Query dated 25th June 2026

This is in response to your email dated 25th June 2026, requesting clarification regarding the Outcome of the Board Meeting concerning the Financial Results of Emerald Tyre Manufacturers Limited, filed with the Exchange on 25th May 2026.

Kindly find below the Company's response to the clarifications requested.

Query 1: Financial results submitted in XBRL with discrepancies - Paid up capital mentioned in actuals instead of Lakhs in Standalone and Consolidated XBRL

Reply: We wish to submit that, due to an inadvertent clerical error while preparing the XBRL instance document, the Paid-up Equity Share Capital was reported in actual figures instead of ₹ in lakhs in both the Standalone and Consolidated XBRL filings.

We wish to clarify that the Financial Results submitted in PDF format to the Exchange contain the correct disclosure, and the discrepancy is confined solely to the XBRL filings. The error is purely clerical in nature and does not impact the financial results or any other disclosures contained therein.

We regret the inadvertent error and inform the Exchange that the Company is filing the revised XBRL for both the Standalone and Consolidated Financial Results with the corrected values. We request the Exchange to kindly take the revised XBRL filings on record. The revised XBRL for Standalone and Consolidation has filed on 30th June 2026.

Query 2: Financial results submitted is not as per format prescribed by SEBI - Disclosure for utilization of issue proceeds is not submitted duly certified by Auditor.

Reply: We wish to submit that, pursuant to NSE Circular No. NSE/CML/2025/20 dated 02nd April 2025, the Statement of Deviation(s) or Variation(s)/Statement of Utilization of Issue Proceeds is required to be filed in XBRL mode along with the Integrated Financial Results, wherever applicable.
