This is in continuation of our intimation dated 29<sup>th</sup> May 2025 regarding the fire accident that occurred during the intervening night of 28<sup>th</sup> and 29<sup>th</sup> May 2025 at one of the Company's Godowns situated at Commercial Property bearing No. 211-240, Survey No. 175, 184, 185, Block No. 22H, Phase IV, Auto Nagar, Guntur District, Andhra Pradesh – 522001.

In this regard, we wish to inform you that:

- The insurance company has accepted the full and final settlement of the claim amounting to **Rs. 7,53,71,836/- (Rupees Seven Crore Fifty-Three Lakh Seventy-One Thousand Eight Hundred Thirty-Six only)** against the claim made by the Company.
- The Company is in the process of receiving the final settlement amount within the next 15 days.
