

Golden Peacock Eco-Innovation Award

Emmbi Industries Limited was conferred with the coveted and prestigious **Golden Peacock Award for Eco-Innovation 2020**. The Award ceremony was virtually hosted by the Institute of Directors on 15th December, 2020. Emmbi was awarded this honor for the invention of 100% Recycable FIBC Bags, which was achieved by using TexturePro, a technology developed in house at the Emmbi Innovation Lab. TexturePro uses a single homopolymer for the entire bag, rather than using different materials for each part as is traditionally done, making it simpler to recycle.
