## **Enser Communications Records Highest-Ever Quarterly Business; Notes Continued Positive Operating Trends.**

Gurugram, January 2, 2026: Enser Communications Limited ("Enser" or "the Company"), a fast-growing Business Process Management company, is pleased to announce that the Company has recorded its **highest level of quarterly business activity to date during Q3 FY26**.

As an SME-listed entity, the Company reports its financial results on a half-yearly basis in accordance with applicable regulatory requirements. This communication is intended to provide a high-level update on business trends, without disclosing unpublished financial information.

The communications and services segment continue to witness **modest, predominantly single-digit growth**, reflecting pricing pressure, fragmentation, and operational scaling challenges. Growth in this environment requires disciplined execution, integration capability, and governance maturity.

Following sustained efforts to consolidate acquired operations and strengthen execution capabilities, the Company has recorded its **highest level of quarterly business activity to date during Q3 FY26**.

Over time, the Company has transitioned from an annual revenue base of approximately **₹25 crore in FY23** to a significantly higher scale, having **crossed the ₹25 crore quarterly business threshold**, reflecting improved operational capacity and execution depth.

Based on **current business visibility, execution progress, and order inflows observed to date**, management notes that operating activity in Q4 FY26 is **tracking at levels higher than Q3 FY26 with continuity of this positive operating trend into subsequent quarters** though subject to market conditions, client demand, and other external factors.

These observations are indicative of improved scalability and normalization of operations following the consolidation phase and should not be construed as financial guidance.

Commenting on the update, **Mr. Rajnish Sarana**, Managing Director of Enser Communication Limited said: *"Our priority over the last few years was to consolidate operations, improve execution discipline, and address the structural challenges of scale in our industry. Q3 FY26 reflects the outcome of those efforts. Based on current visibility and execution progress, business activity in Q4 FY26 is tracking higher than Q3, with early indicators suggesting continuity of this trend, subject to prevailing conditions. Our focus remains on disciplined execution rather than short-term outcomes."*

Over the past few quarters, Enser has focused on integrating acquired businesses, strengthening internal controls, and building scalable delivery platforms. This phase, while operationally intensive, has enabled the Company to move from stabilization towards **more consistent and sequential execution**.
