EBITDA	EBITDA provides information regarding the operational efficiency of the business.
EBITDA Margin (%)	EBITDA Margin (%) is an indicator of the operational profitability and financial performance of business.
PAT	Profit after tax provides information regarding the overall profitability of the business.
PAT Margin (%)	PAT Margin (%) is an indicator of overall profitability and financial performance of business.
Net Worth	Net Worth is used by the management to ascertain the value created by the entity and provide a snapshot of current financial position of the entity.
Return on Net Worth (%)	Return on Net Worth (%) provides how efficiently the company leverages its net assets to generate income.
Order Book	Order Book shall means estimated contract value of unexecuted portion of company's existing assigned EPC/HAM contracts and is an indicator of visibility of future revenue for the company.
Order Inflow	Order Inflow shows the ability of the company to win bids on consistent basis and reflects year on year growth and expansion in business.
