AI-Social Tech Professionals form a core part of the CDX framework. These professionals are intended to enable dynamic collaboration and communication among stakeholders and to work alongside legislators to translate dialogue into measurable outcomes at the constituency level. The sandbox session served as a preparatory step to refine this approach and gather inputs, expectations, and perspectives from participating stakeholders.

EQUIPPP, which stands for Expression of Equity Interest in Public-Private Partnerships, is a book-building and collaboration platform aimed at fostering cross-sector collaborations and evolving Public-Private Partnerships.
