The Company, through this communication wishes to bring to the notice of the members, following changes in the Postal Ballot Notice, as detailed below:

Revised Valuation Report

The revised valuation report dated December 5, 2025 as referred to in the Corrigendum I (available at this <u>link</u>), has been further updated by the valuer to remove all references to the DCF methodology (under the Income Approach) applied by them to derive the valuation, in furtherance of resolution of the queries received from the stock exchanges. Accordingly, the valuer has issued an updated valuation report dated December 17, 2025, a copy of which can be accessed at https://eris.co.in/wp-content/uploads/2025/12/Revised-Valuation-Report-Share-Swap-Acquisition-of-SPL-17.12.25.pdf.
