We draw your attention to our letter dated 30 September 2022, intimating the meeting of the Board of Directors for consideration of unaudited financial results for the year ended 30 September 2022 to be held on 11 November 2022, Friday through Video Conferencing Mode (VCM). We would like to further inform you that the Board of Directors based on the unaudited financial results for the year period ended 30 September 2022 may recommend Interim Dividend, if any, to the Equity shareholders of the Company for the Financial Year ending 31 March 2023.
