**Escorts Kubota Limited sold 10,354 tractors in May 2025**

**Faridabad, June 1<sup>st</sup>, 2025:** Escorts Kubota Limited Agri Machinery Business Division in May 2025 sold 10,354 tractors as against 10,286 tractors sold in May 2024.

**Domestic tractor sales** in May 2025 were at 9,703 tractors as against 9,906 tractors in May 2024. The timely onset of the monsoon season has uplifted spirits on the ground. Agricultural activities for the upcoming Kharif crops are set to begin as planned. Moving forward, we anticipate that this positive momentum will persist, driven by above normal monsoon, sufficient water reservoir levels and improved liquidity.

**Export tractor sales** in May 2025 were at 651 tractors registering a growth of 71.3 percent as against 380 tractors sold in May 2024.
