#### Introduction

- 1. We have reviewed the accompanying Statement of Consolidated Unaudited Financial Results of Essar Shipping Limited (the "Parent") and its subsidiaries (the Company and its subsidiaries together referred to as "the Group"), and its share of the net profit/(loss) after tax and total comprehensive income / loss of its associates and joint ventures for the quarter and half year ended 30th September, 2025 together with notes thereon ("the Statement") being submitted by the Parent pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations"). Attention is drawn to the fact that the consolidated figures for the corresponding quarter and half year ended 30th September, 2025, as reported in these financial results have been approved by the Parent's Board of Directors, but have not been subjected to review.
- 2. This Statement, which is the responsibility of the Parent's Management and approved by the Parent's Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013, and other accounting principles generally accepted in India. Our responsibility is to express a conclusion on the Statement based on our review.

# Scope of review

3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 - "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India. A review of interim financial information consists of making inquiries, primarily of persons responsible for the financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing and consequently does not enable us to obtain an assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

# Conclusion

5. Based on our review conducted and procedures performed stated in the paragraphs above, on the consideration of review reports of the auditors of the subsidiary companies not reviewed by us and management certified unaudited financial results of subsidiaries referred to in paragraph 11 and 12 below, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with recognition and measurement principles laid down in the aforesaid Indian Accounting Standards ('Ind AS') specified under Section 133 of the Companies Act, 2013 as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirement) Regulations, 2015, as amended, including the manner in which it is disclosed or that it contains any material misstatements

# Material Uncertainty Related to Going Concern

- 6. We draw attention to Note Nos. 5, 6 and 8 of the Unaudited Consolidated Financial Results, wherein it is stated that:
  - The Group's current liabilities exceed its current assets as at September 30, 2025.
  - One of the lenders of a subsidiary (which has gone into liquidation), for which the Parent is a guarantor, has filed applications before various forums for recovery of overdue amounts and enforcement of guarantees.
  - Key Management & Supervision Agreement has been terminated with a group company which was the major revenue stream.

- The Parent has disposed of most of its assets and certain investments in order to repay its outstanding dues to lenders and vendors.
- The net worth of the Group has eroded, and the Group has been continuously incurring operational losses for the past several years.
- The Group has adverse key financial ratios and is unable to pay creditors on due dates.
- The Group has undertaken restructuring of existing debt obligations.
- The Group is substantially dependent on the success of specific projects or assets for its future revenue generation.
- There are pending legal proceedings and similar matters that may jeopardize the Group's ability to continue its operations.

The above factors indicate the existence of a material uncertainty that may cast significant doubt on the Group's ability to continue as a going concern.

During the quarter, the Parent has booked charter hire income on a tug. Parent's management is actively pursuing measures to improve the Parent's financial position and undertaking steps to mitigate the mismatch between current assets and current liabilities during the year. In view of these, the Financials have been prepared on a Going Concern basis.

We have relied on the management's representation as stated above, and based on the same, the Consolidated Financial Results of the Group have been prepared on a going concern basis.

Our conclusion is not modified in respect of this matter.

# **Emphasis of Matter**

- 7. We draw attention to Note No. 7 of the Consolidated Financial Results relating to the agreement for sale of shares held by the Parent in a subsidiary. The sale of such shares has been accounted partly in FY 2024-25. During the previous quarter, the Parent received the balance sale consideration towards its stake in the foreign subsidiary, recognized the sale of shares to the extent of consideration received, and recorded the corresponding profit including foreign exchange gain. The transfer of shares in the name of the buyer has been completed, and the requisite RBI compliances are under process.
- 8. We draw attention to Note No. 9 of the Consolidated Financial Results where, during the quarter and half year ended 30th September 2025, the Company has received a part of the security deposit from a bank in connection with the OTS offer made on behalf of its subsidiary company. Since the amount had earlier been considered irrecoverable and impaired, the recovery has been recognized as an exceptional gain in the current year.

Our conclusion is not modified in respect of this matter.

9. The accompanying Statement does not include the financial results of the following entities:

OGD Services Limited - The Company has not been consolidated as it is under liquidation.

Seros Oilfields Services India Limited - The Company has not been consolidated since its immediate parent/associate/joint venture is under liquidation process.

#### Joint Venture:

Seros Drilling Private Limited - The Company has not been consolidated since its immediate parent/associate/joint venture is under liquidation process.

- 10. The Parent has netted off ₹331.26 crore payable to a wholly owned overseas subsidiary with the amount receivable from the said subsidiary. The said adjustment is subject to the approval of the relevant regulatory authorities, for which the application is currently pending.
- 11. The accompanying Statement includes the unaudited interim standalone financial results, in respect of-

A subsidiary, whose unaudited interim financial results reflect total assets of Rs 73.33 crore as at 30<sup>th</sup> September, 2025, total revenues of Nil for the quarter and half year ended 30th September, 2025 respectively, total loss after tax of Rs. 2.43 crore Rs. 4.96 crore for the guarter and half year ended 30th September, 2025 respectively total comprehensive loss of Rs.2.43 crore and Rs. 4.96 crore for the quarter and half year ended 30th September, 2025 respectively as considered in the Statement which have been reviewed by us.

The subsidiary is located outside India and its financial results have been prepared in accordance with the accounting principles generally accepted in that country. The Parent Company's management has converted those financial results from the accounting principles generally accepted in that country to the accounting principles generally accepted in India to enable consolidation with the Parent Company's financial statements.

Our conclusion on the Statement is not modified in respect of the above matter

12. We did not review the financial results of one subsidiary included in the consolidated unaudited financial results, whose financial results reflect total assets of Rs.417.83 crore as at 30th September, 2025 and total revenues of Rs. NIL and Rs. NIL, total net loss after tax of Rs 7.92 crore and Rs. 18.31 crore and total comprehensive loss of Rs. 7.92 crore and Rs 18.31 crore for the quarter and half yearly ended 30th September, 2025 respectively, as considered in the consolidated unaudited financial results. These financial results have been reviewed by other auditors whose reports have been furnished to us by the Management and such other auditors.

Our conclusion on the Statement is not modified in respect of the above matter

13. The consolidated unaudited financial results include the interim financial results of two of its subsidiaries which have not been reviewed and audited by their auditors, whose financial results reflect total assets of Rs.0.23 crore as at 30th September, 2025 and total revenues of Rs. NIL and Rs. NIL, total net loss after tax of Rs. 0.42 crore and Rs 1.84 crore and total comprehensive loss of Rs. 0.42 crore and Rs 1.84 crore for the quarter and half yearly ended 30th September, 2025 respectively, as considered in the consolidated unaudited financial results. According to the information and explanations given to us by the Management, these interim financial results are not material to the Group.

Our conclusion on the Statement is not modified in respect of the above matter.

The Results for the quarter and year ended September 30, 2025 are available on the Bombay Stock Exchange website (URL: www.bseindia.com/corporates), the National Stock Exchange website (URL: www.nseindia.com/corporates) and on the Company's website (URL: www.essar.com).

As on 30 September 2025, the net worth of the Company is eroded as it is incurring operating losses since last several years. The Company has accumulated losses of ₹ 5,327.39 crore as against share capital and reserves of ₹2,956.62 crore and the Company's current liabilities exceeds its current assets. During the quarter, the Holding Company has booked charter hire income on tug. Management is actively pursuing measures to improve the Company's financial position and undertaking steps to mitigate the mismatch between current assets and current liabilities during the year. In view of these, the Financials have been prepared on a Going Concern basis.

One of the lender to a Subsidiary Company (where the Holding Company is a Guarantor) has filed suit against the Company before the NCLT/ DRT for recovery of loans granted to the subsidiary company (Holding Company is a Guarantor). The said subsidiary Company is under liquidation. The Holding Company is in advanced stage of negotiations with the lender for One Time Settlement. The settlement with this lender is expected in next quarter. During the previous year, the Holding company has made settlement with other lender of the said subsidiary.

Based on shareholders approval vide Annual General Meeting dated 29 September 2023 and second approval accorded by way of postal ballot through remote e-voting dated 23 July 2024, the Holding Company entered into Share Purchase Agreement to sell equity shares of one of its foreign subsidiary company during the preceding financial year. During the previous quarter, the Holding Company has received amount of ₹ 71.88 crore towards balance sale of stake in the foreign subsidiary company. The Holding Company has recognized the sale of shares to the extent of consideration received and booked profit of ₹ 47.81 crore (including ₹ 21.89 Crore on account of foreign exchange gain). Transfer of shares in the name of the buyer is completed and required RBI compliances are under process.

The management agreement of the Holding Company with a group company was terminated effective 31 May 2025 and with a subsidiary company effective 30 June 2025.

During the previous year, the Holding Company had paid ₹5.50 crores as part of a One-Time Settlement to a lender of a subsidiary (under liquidation) in its capacity as guarantor. The amount was impaired and disclosed as an exceptional item. The lender refunded the said amount during the quarter and accordingly, the Holding Company has reversed the provision.

# Introduction

- 1. We have reviewed the accompanying statement of Standalone Unaudited Financial Results of Essar Shipping Limited ("the Company") for the quarter and half year ended 30th September, 2025 together with notes thereon ("the Statement") being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").
- 2. The Company's Management is responsible for the preparation of the Statement in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34, (Ind AS 34) "Interim Financial Reporting" prescribed under Section 133 of the Companies Act, 2013 as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India and in compliance with Regulation 33 of the Listing Regulations. The Statement has been approved by the Company's Board of Directors. Our responsibility is to issue a report on the Statement based on our review.

# Scope of review

3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 - "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review of interim financial information consists of making inquiries, primarily of persons responsible for the financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing and consequently does not enable us to obtain an assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.



#### Conclusion

4. Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying Statement of Standalone Unaudited Financial Results, prepared in accordance with the recognition and measurement principles laid down in the aforesaid Ind AS 34 specified under Section 133 of the Companies Act 2013, as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of Regulation 33 of the Listing Regulations including the manner in which it is to be disclosed, or that it contains any material misstatement.

# **Material Uncertainty Related to Going Concern**

- 5. We draw attention to Note No. 4, Note No. 5 and Note No. 7 of the Standalone Financial Results wherein it is stated that: -
  - The Company's current liabilities exceed its current assets as on September 30, 2025.
  - One of the lenders of the Company's Subsidiary (which has gone into liquidation)
    where the Company is a Guarantor, has filed applications before various forums for
    recovery of overdue amounts and/or enforcement of guarantees.
  - Key Management & Supervision Agreement has been terminated with a group company which was the major revenue stream.
  - The Company has disposed of most of its assets and some of the investments to pay
    off its outstanding dues to lenders/vendors.
  - The net worth of the Company is eroded and it is continuously incurring operational losses since last several years.
  - The Company has adverse key financial ratios and is unable to pay creditors on due dates.
  - The Company has undertaken restructuring of existing debt obligations.
  - There are pending legal proceedings and similar matters that may jeopardize the Company's ability to continue its operations.

The above factors give rise to a material uncertainty related to the Company's ability to continue as a Going Concern.

During the quarter, the Company has booked charter hire income on a tug owned by the Company. Management is actively pursuing measures to improve the Company's financial position and undertaking steps to mitigate the mismatch between current assets and current liabilities during the year. In view of these, the Financials have been prepared on a Going Concern basis.

We have relied on the management representations, as above, and based on the same, the Standalone Financial Results have been prepared by the management on going concern basis.

Our conclusion on the Standalone Financial Results is not modified for the above matters.

# **Emphasis of Matter**

6. We draw attention to Note No. 6 of the Standalone Financial Results relating to the agreement for sale of shares held by the Parent in a subsidiary. The sale of such shares has been accounted partly in FY 2024–25. During the previous quarter, the Parent received the

balance sale consideration towards its stake in the foreign subsidiary, recognized the sale of shares to the extent of consideration received, and recorded the corresponding profit including foreign exchange gain. The transfer of shares in the name of the buyer has been completed, and the requisite RBI compliances are under process.

- 7. We draw attention to Note No. 9 of the Standalone Financial Results where, during the quarter and half year ended 30th September 2025, the Company has received a part of the security deposit from a bank in connection with the OTS offer made on behalf of its subsidiary company. Since the amount had earlier been considered irrecoverable and impaired, the recovery has been recognized as an exceptional gain in the current year.
- 8. We draw attention to Note No. 10 of Standalone Financial Results that the Company has received an amount of Rs. 102.43 crores from its subsidiary, which has been recognized as an exceptional gain in the current year, as the same was previously impaired due to nonrecoverability.

Our conclusion on the Standalone Financial Results is not modified for the above matters.

#### Other Matter

9. The Company has netted off Rs. 331.26 crores payable to a wholly owned overseas subsidiary with the amount receivable from the said subsidiary. This is subject to pending application and approval from the regulatory authorities.

Our conclusion on the Standalone Financial Results is not modified for the above matters.

The Company has accumulated losses of ₹ 6,381.56 crore as against share capital and reserves of ₹5,218.13 crore and the Company's current liabilities exceeds its current assets. During the quarter, the Company has booked charter hire income on tug. Management is actively pursuing measures to improve the Company's financial position and undertaking steps to mitigate the mismatch between current assets and current liabilities during the year. In view of these, the Financials have been prepared on a Going Concern basis.

One of the lender to a Subsidiary Company (where the Company is a Guarantor) has filed suit against the Company before the NCLT/ DRT for recovery of loans granted to the subsidiary company (Company is a Guarantor).

Based on shareholders approval vide Annual General Meeting dated 29 September 2023 and second approval accorded by way of postal ballot through remote e-voting dated 23 July 2024, the Company entered into Share Purchase Agreement to sell equity shares of one of its foreign subsidiary company in preceding financial year. During the previous quarter, the Company has received amount of ₹ 71.88 crore towards balance sale of stake in the foreign subsidiary company. The Company has recognized the sale of shares to the extent of consideration received and booked profit of ₹ 47.78 crore (including ₹ 21.89 Crore on account of foreign exchange gain). Transfer of shares in the name of the buyer is completed and required RBI compliances are under process.
